To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2)-**artaxt**ed mobile phone (pagesyou-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgeaor auto loan). The transcript displays online upon successful completion of the IRS's tate p authentication.
