## B. Dependent Student's Income Information to Be Verified

**1. TAX RETURN FILERS** Instructions: Complete this section if you, the student, filed or will file a 2022 income tax return with the IRS. The best way to verify income is to provide Federal Tax Information Consent and use the IRS Data Exchange within the FAFSA Online Application. If the student has not already used the tool, go to [studentaid.gov](http://studentaid.gov) in to the student's FAFSA. Select "Make Corrections," and navigate to the income section of the application. Follow the instructions to provide FTI Consent in order for the tax information to be extracted into the application. It is important to note that without FTI Consent, financial aid eligibility cannot be determined. If the IRS Data Exchange cannot be used, you may request a 2022 IRS Tax Return Transcript one of four ways:

- Get Transcript by Mail- Go to [www.irs.gov](http://www.irs.gov), click "Get Your Tax Record." Click "Get Transcript by Mail." Make sure to request the "Return Transcript" and NOT the "Account Transcript." The transcript is generally received within 10 business days from the IRS's receipt of the online request.
- Get Transcript Online Go to [www.irs.gov](http://www.irs.gov), click "Get Your Tax Record." Click "Get Transcript Online." Make sure to request the "Return Transcript" and NOT the "Account Transcript." To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2) enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript displays online upon successful completion of the IRS's two-step authentication.
- Automated Telephone Request 1-800-908-9946. Transcript is generally received within 10 business days from the IRS's receipt of the telephone request.
- Paper Request Form IRS Form 4506EZ or IRS Form 4506 The transcript is generally received within 10 business days from the IRS's receipt of the paper request form.
